

Investment Theme—Direct Connection

The Direct Connection of computers to the real world has enabled the technology revolution of the past 15 years, driving an acceleration in tech adoption simultaneously across all industry verticals. With every other industry investing its excess returns in technology, we expect the IT sector to continue to outperform the broader market as it steals the growth from the rest of the economy. The Fund focuses on the companies enabling Direct Connection, giving it exposure to the most exciting developments in the sector without needing to chase over-hyped themes or invest in over-valued stocks.



William de Gale's Monthly Comment

In last month's commentary I suggested that signs of possible weakness in the US economy might begin to worry investors, and indeed a sharp sell-off for the Technology sector started in mid-July, as US macro indicators began to weaken, while June quarter results failed to provide the unequivocal evidence of continued strong AI spend that investors were hoping for. Despite a big bounce on the final day of the month, the BlueBox Global Technology Fund was down 3.7% in July, reducing year-to-date gains to 16.6%, underperforming the benchmark, which was up 21.7% YTD.

The portfolio's biggest laggards were Lam Research (-13%), Cadence Design Systems (-13%), ARM Holdings (-12%), Advanced Micro Devices (-11%) and ASML Holding (-11%), all of which are semiconductor-related, and beneficiaries of generative AI excitement over the past year. The strongest positive performances came from Murata Manufacturing (+8%), Palantir Technologies (+6%), Texas Instruments (+5%) and Monolithic Power Systems (+5%).

It looks as though we may be set up for a typical pattern of weakness for the Technology sector over the summer, followed by a strong rebound in the fourth quarter. During June quarter reporting seasons, managements are often quite cautious with fullyear guidance, as the big second half is only just starting, so investors looking for bullish forecasts to sustain an investment narrative may find themselves disappointed, especially if broader macro headwinds appear to be rising, and this could be what is happening currently: while there were some weak results (such as Intel, which we don't hold), most came in absolutely fine or even better. At some point AI-driven tech spend will have to slow, especially given its currently unproven economics, and while there doesn't seem to be much evidence that this is happening yet - just the reverse - managements aren't going to fully and publicly commit themselves to bullish forecasts barely halfway through the vear.

Meanwhile US employment data is a little weaker, consumer default rates are rising and ISM manufacturing surprised on the downside, creating a bear case for the US economy, should one be looking for it. It still seems more like a soft landing than a recession, but after such a strong start to the year, investors are nervous and looking for the downside. Geopolitical factors such as the US election, Gaza conflict, China/US tensions and the war in Ukraine all currently add to uncertainty. This combination of macro doubts, geopolitical risks and a lack of clear affirmation of tech strength is resulting in volatility and market weakness.

At present this feels more like a typical summer correction for the Technology sector: there is generally very little sector-specific data until the next reporting season in October/November, which can then lead to a sharp rebound in the fourth quarter – the familiar late-October bounce. Companies report solid September quarters, and managements (by then only a few weeks from year end) can be more aggressive in their full-year guidance and start to talk bullishly about the year to come. But in the meantime we are keeping an eye on the undoubted risks, ready to take some cyclicality off the table if required.

However, whatever the short-term gyrations of market sentiment, we see no evidence that the overall trend of 15% growth for the Technology sector as a whole is at risk: in the real world vast sums are still being spent across a wide spectrum of technology, as companies develop and deploy successive rounds of tech-driven disruption in every walk of life, enabled by the Direct Connection of systems to the real world. Technology enablers continue to be the main beneficiaries, stealing almost all the profit growth from the rest of the market, as they have done since 2007. These very profitable enablers remain the main engine of profit growth globally, giving BlueBox investors exposure to the strongest technology trends, without the absurd valuations and poor business models of many of the high-profile, but profitless, disrupters.
