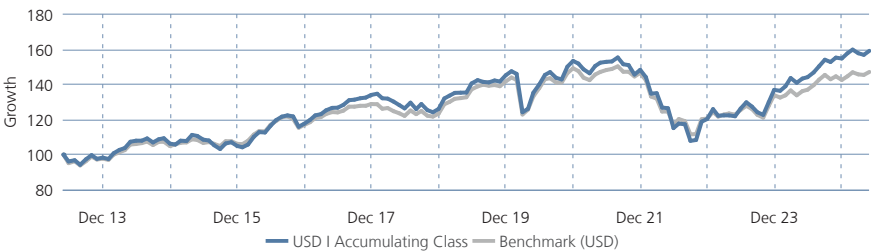

RISK CONSIDERATIONS
