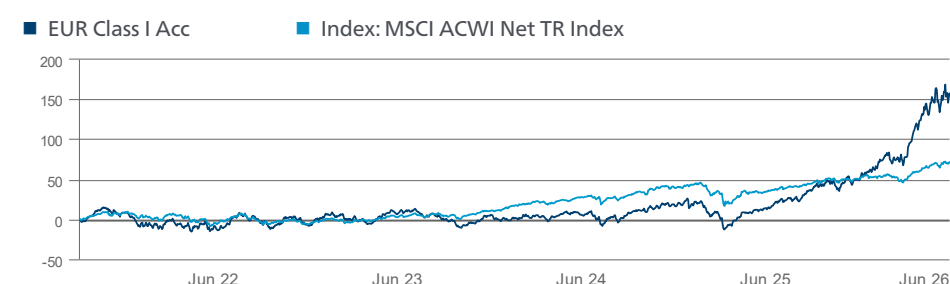

Fund Manager's Comments

Market review

Crude oil prices (WTI) dropped to \$70 a barrel following an interim 60-day peace agreement and Memorandum of Understanding between the US and Iran that effectively reopened the Strait of Hormuz. Non-tech sectors drove market resilience in June through capital rotation. The US 10-year Treasury yield finished the month at 4.47%, up from 4.44% the previous month.

Fund performance

The Fund (USD I Acc Share Class) gained 2.5% during the month, outperforming the broader market, as represented by the MSCI All Country World Net Total Return Index, which lost 0.8% (both figures in dollar terms).

Marvell Technology, the custom AI silicon and data centre interconnect company, jumped following a highly successful keynote at the Computex conference in Taiwan, with the surge further catalysed by NVIDIA CEO Jensen Huang's prediction of it being "the next trillion-dollar company".

Corning shares surged following new updates on its glass optical interconnect technology for AI data centres. This follows the company's recent announcement of a \$10bn revenue target for its photonics business unit by 2030 which is fuelled by explosive industry demand for high-speed AI network infrastructure.

Likewise, Coherent saw its stock climb on reports that demand continued to exceed supply alongside accelerating product adoption.

Other positive performance contributors included Panasonic, Renesas Electronics and Yuanjie Semiconductor Technology.

Delta Electronics, the AI data centre power equipment supplier, receded on reports of potential delays of next-generation 800VDC power

architectures for AI data centres.

EOS Energy Enterprises, the long-duration energy storage supplier, was lower as it announced a new rights offering.

LG Energy Solution, the South Korean battery manufacturer, was down on continued worries about weak electric vehicle sales.

Other negative performance contributors included Sumitomo Electric Industries, Broadcom and ON Semiconductor.

Fund activity

We increased the Fund's positions in Corning, Broadcom, Linde and NXP Semiconductor, and reduced those in MP Materials, Microchip Technology and EOS Energy Enterprises.

Market outlook

The gradual rise of oil and natural gas shipments through the Strait of Hormuz helped significantly reduce energy-induced inflationary risks. This will redirect market focus toward the fundamentals of the AI boom, alongside the related inflationary pressures and supply chain constraints.

The fundamentals of the portfolio's core holdings addressing the electrification of the global energy system remain strong. We prioritise segments exhibiting robust structural growth, specifically targeting clean power generation, smart grid and energy storage solutions, power electronics, the electric vehicle ecosystem, humanoid robotics, electric heat pumps and improving the energy efficiency of Big Data infrastructure.

Our portfolio maintains considerable exposure to the AI theme, strategically weighted towards technology enablers that improve data-processing efficiencies and essential electrical infrastructure suppliers. We anticipate the coming years will be decisive in determining the leaders of the AI race and we expect significant capital expenditure allocations to persist across the industry.
