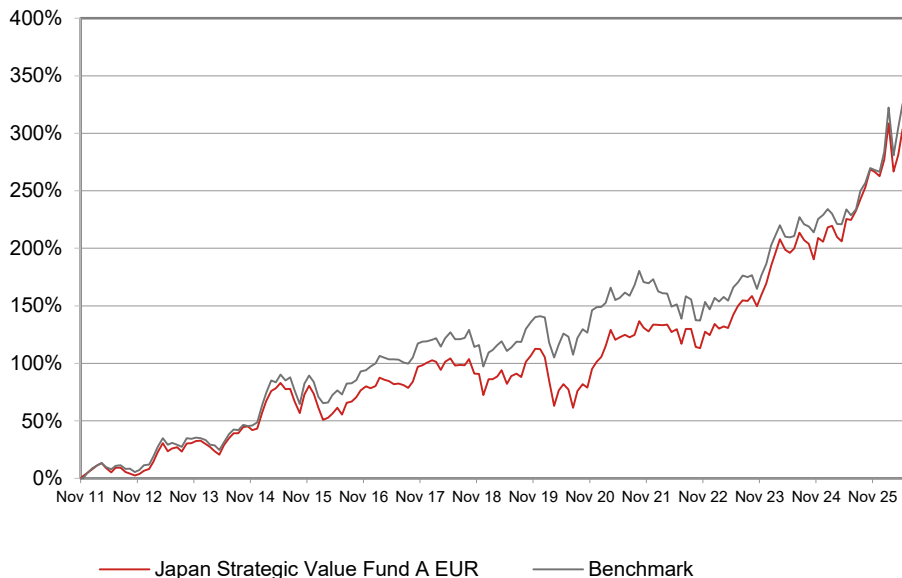


INVESTMENT OBJECTIVE

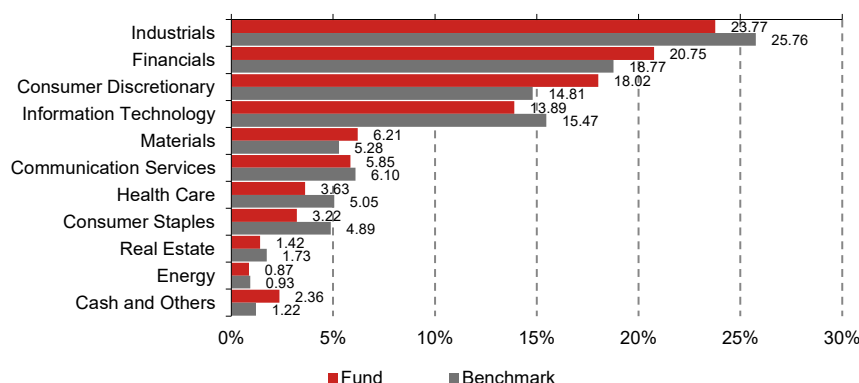
