### Investment Objective

The fund invests primarily in global equity markets striving to build a diversified portfolio with a focus on theme, sector and stock selection. The exposure to the Emerging Markets is restricted to 50 % while convertible bonds may not exceed 15 % of the fund's assets. Its investment objective is to attain capital growth over the long term. Sustainability aspects are taken into account by the fund management. 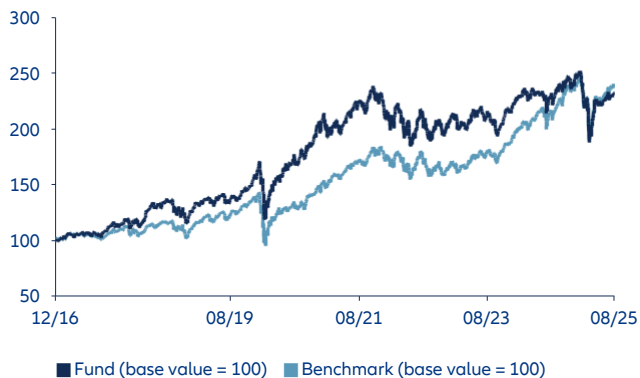

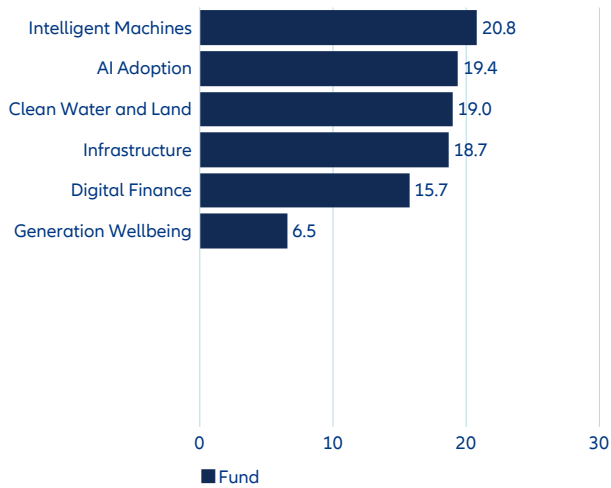

Portfolio Structure <sup>7</sup>

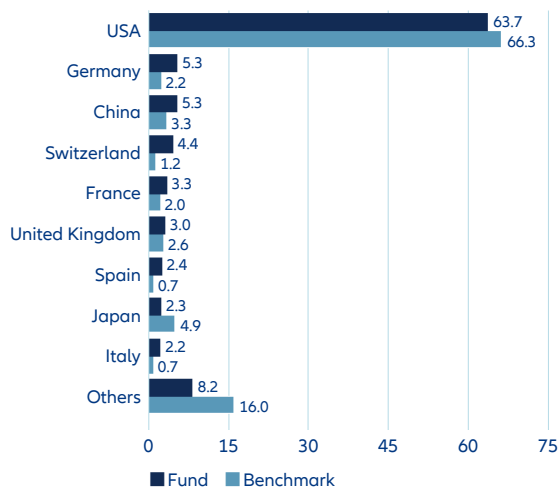
Theme allocation (%)
