Performance commentary

Based on transaction prices, the fund's return was 1.50%.

The Robeco Afrika Fund posted a flat return in June, outperforming its reference index (-0.79%). Developed markets gained 1.5% while emerging markets returned 0.8% over the same period, both measured in EUR terms. African equity markets delivered a mixed picture during the month, with a wide dispersion of nearly 19 percentage points between the best and worst-performing focus countries. Tunisia led the way with a strong 13.7% return, followed by Kenya (+12.6%), Mauritius (+8.4%) and Ghana (+8.3%), the latter supported by a meaningful 5.8% appreciation of the Ghanaian cedi against the euro. Egypt gained 4.9%. Zambia advanced 3.6%, Botswana gained 1.5% and Senegal edged up 0.2%. On the negative side, Morocco declined 2.4%, South Africa lost 4.7% and Nigeria was the weakest performer with a 5.3% loss.

Market development

South Africa's GDP growth accelerated from 0.8% in Q4 to 1.9% in Q1, beating the consensus expectation. Growth was driven by higher exports and strong agricultural output growth. Positive was also that the current account surplus rose from 0.6% of GDP in Q4 to 2.5% in Q1 and that was better than expected. Monthly indicators were mixed. Mining production surged in April by 8.2%, more than the consensus estimate. However, retail sales (+1.3%) and manufacturing production (-2.9%) disappointed in April. Vehicles sales in May rose 12.8%. Inflation rose from 4.0% in April to 4.5% in May. That was less than most economists had projected. Zambia's economic growth accelerated from 1.6% to 7.7%, while Ghana grew 6.4%. Morocco expanded 4.6%. Egypt and the IMF reached a staff-level agreement, paving the way for approximately USD 1.6 bln in new financing. Nigeria's trade surplus expanded and the current account surplus increased from USD 1.4 bln in Q4 to USD 5.0 bln in Q1 due to higher crude oil export receipts and lower refined oil products imports as the Dangote oil refinery ramped up production.

Expectation of fund manager

The long-term prospects for the African region are good. Firstly, commodity demand from China and other countries is likely to grow in the long run. This should result in higher tax income and employment, which in turn should boost demand by local consumers. Secondly, the business climate is improving. In an international context, most African countries currently do not score well, but governments are actively trying to reduce bureaucracy. Thirdly, investments in infrastructure are reducing logistics problems, which should boost economic growth and company earnings. Lastly, many companies now trade at low price/earnings multiples and have high dividend yields compared to other regions.

Sector allocation

The most important sector is financials. Through banks, we try to benefit from income growth and rising demand for loans from both companies and consumers. Other important sectors are consumer discretionary, telecom and materials.

Country / Region allocation

The fund invests in companies that are predominantly active in Africa. South Africa is the biggest country in the portfolio because of its market size, liquidity, good corporate governance and the fact that many South African companies are also active in other countries on the continent. Other countries are Nigeria, Kenya, Egypt, Ghana, Zambia, Botswana, Morocco, Mauritius, Tunisia and Senegal. In addition to these, we hold a number of companies that are predominantly active in Africa but have a stock market listing in Portugal or the UK. These are mainly telecom and construction companies.

Currency allocation

The fund does not actively hedge its currency exposure. The currency allocation reflects the fact that stock prices of some companies are quoted in Canadian/US dollars, euros or British pounds. However, these companies are active in countries such as Algeria, Angola, Kenya, Nigeria and Tanzania.

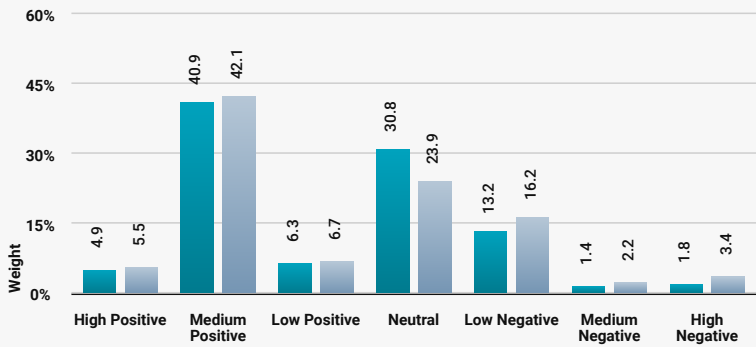

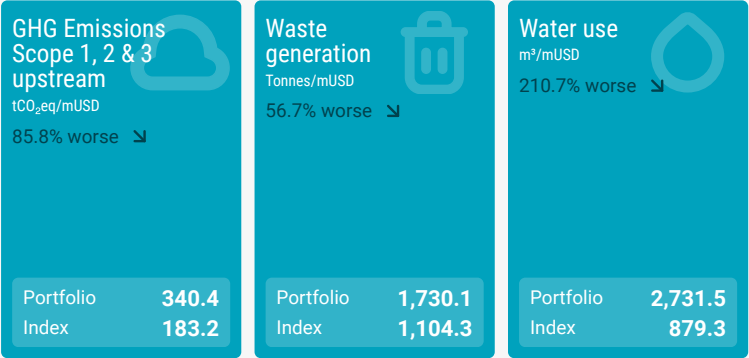
SDG Impact Alignment ¹

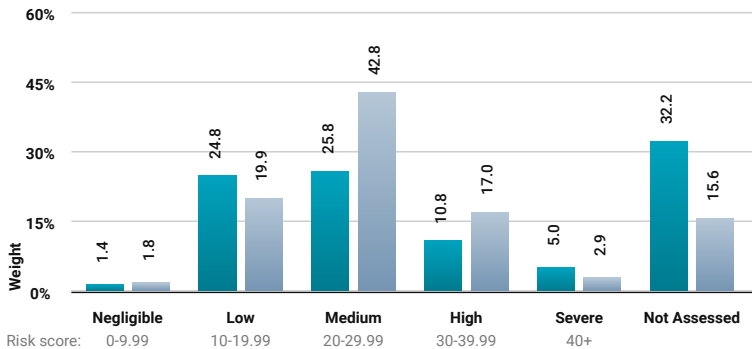

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in the Netherlands. The fund is managed as a 'naamloze vennootschap' (public limited company). The fund has the status of 'fiscal investment institution' in the sense of article 28 of the Dutch Corporate-Income Tax Act 1969, and, as such, is taxed at a corporate-income tax rate of 0%. The fund is obliged to pay out the realized current income in the form of dividend within 8 months after the end of the financial year. From 1 January 2007 the fund withholds Dutch dividend tax at a rate of 15% from these dividend payments. The fund can in principle use the Dutch treaty network to partially recover any withholding tax on its income.

Dividend policy

In principle, the fund distributes dividend on an annual basis.
