Fundamental analysis is performed on each of the three performance drivers: country allocation, duration (interest rate sensitivity) management and yield curve positioning. Country ESG scores are part of our bottom-up analysis.

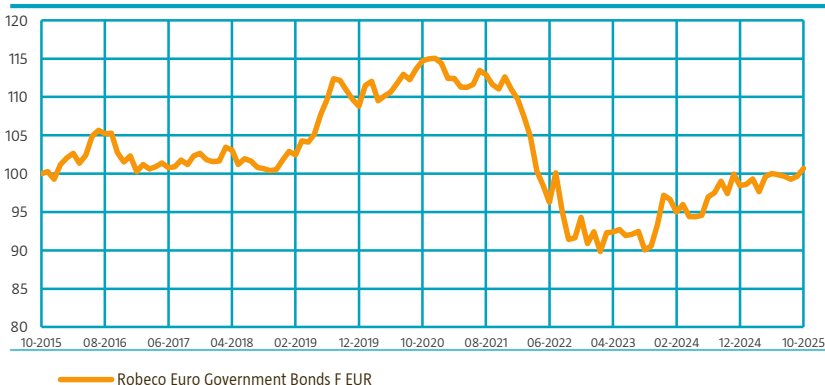

Performance

Based on transaction prices, the fund's return was 1.04%.

The fund posted a positive return over the month, also above its index. Both the overweight duration position and the yield curve steepening strategy contributed to relative returns over the month. The ultra long end of the curve remains vulnerable in our view, now that more and more Dutch pension funds get approval from the DNB to transition per January 2026. Country allocation also contributed positively. Positioning in France slightly detracted, but overweight positions in Spain, Italy and Greece contributed, as spreads managed to tighten further, driven by the positive risk sentiment in markets. Within EM, the overweight in Bulgaria contributed in particular, as the country gets closer to EU inclusion. SSA allocation also added to performance; especially the position in EU bonds was supportive.

Market development

Government bond returns were positive in October, with US Treasuries up 0.5% and German Bunds gaining 0.7%. Bonds benefited from a small period of risk-off sentiment, related to US-China trade tensions and from stable US inflation data. While the Fed cut rates by 25 bps on 29 October, the FOMC meeting was still seen as hawkish. In the press conference Fed chair Powell pushed back on rate cutting expectations for their 10 December meeting. UK Gilts had a strong month, with a return of 2.6%. Weaker labor market data and lower than expected inflation lead to more optimistic views on the potential for rate cuts by the Bank of England. The ECB decided to keep rates on hold on 30 October and the meeting had little impact on yields. French OATs managed to keep pace with German Bunds, despite the political unrest and rating downgrade to A+ by S&P. Moody's kept France at its AA3 rating, but lowered the outlook to negative.

Expectation of fund manager

As the US government shutdown continues, the lack of fresh data makes it more difficult for the Fed to decide on rates. Ultimately, we think the Fed is willing to cut rates to approximately 3.25%, which can be seen as the lower end of the 3-4% neutral range. This should support US Treasuries in the front and belly of the curve. The ECB looks firmly on hold, which will probably reduce volatility in euro rates. Still, the steepening of the euro yield curve is expected to continue, on the prospect of increased supply and less pension fund demand for long-end duration. French political and fiscal developments remain a risk for OATs, but the overall spread climate in euro government bonds remains supported by improving fundamentals and upgrades in credit ratings.

Sector allocation

Robeco Euro Government Bonds predominantly invests in euro-denominated government and government-related bonds issued by Eurozone countries or affiliated entities. Exposure to highly rated SSA bonds amounts to approximately 8%, while around 4% of the fund is invested in emerging hard currency bonds, such as Bulgaria and Romania. ESG factors are considered when assessing the fundamental credit quality of individual issuers. At the end of the month, around 21% of the fund was invested in green, social, and sustainable bonds.

Duration allocation

The overall duration of the fund is 7.4 years, versus 7.2 years for the index. Euro duration was around the index level at month-end, while the fund holds a long position in the UK, based on somewhat better-than-expected economic data, which allows the BoE to continue on its gradual rate cutting path. For now, limited cuts are priced in for the coming quarters. The ECB is clearly in a pause mode for the time being. We see chances of an additional rate cut to be higher than that of a rate hike next year, meaning short-dated bond yields have limited scope to rise, but the ECB is clearly not in any hurry to do anything for now. Longer-dated bond yields in Europe could rise further, based on additional bond issuance and potential flows from the Dutch pension system.

Rating allocation

Approximately 35% of the fund is invested in AAA-rated bonds, comprising German and Dutch government bonds and high-quality government-related issuers such as the EU, BNG, and KfW. The fund remains underweight in French government bonds (A-rated), and is now circa 9% overweight in BBB-rated bonds, including Bulgarian, Greek, and Italian government securities.

Country allocation

The portfolio remains underweight in French government bonds in market weight % terms, but switched to a more neutral duration stance in duration in France, as we anticipated a survival of the Lecornu government past month. That said, we remain cautious. Budget negotiations are taking place, but all concessions given (like the delay of the pension reform) to prevent new parliamentary elections in coming weeks will eventually lead to more budgetary challenges in the future. Overweight positions in Italy and Spain were also reduced, locking in gains after the recent tightening. We have held on to our Greek bonds, despite tight valuations, as bond scarcity will likely push spreads even tighter. Bulgaria will enter the EU per January 2026, which also means EGB benchmark inclusion per March 2026. We expect these bonds to tighten in the run-up to and following this inclusion, as a whole new investor base will have to buy these relatively scarce bonds.

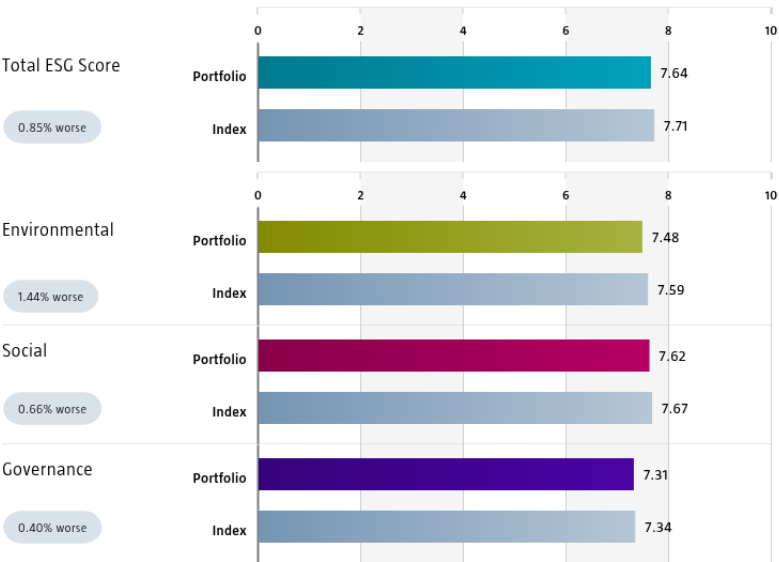

Sustainability

The fund incorporates sustainability in the investment process via exclusions, negative screening, ESG integration and a minimum average country sustainability ranking score as well as a minimum allocation to ESG-labeled bonds. The fund complies with Robeco's exclusion policy for countries and does not invest in countries where serious violations of human rights or a collapse of the governance structure take place, or if countries are subject to UN, EU or US sanctions. In addition, the fund excludes the 15% worst ranked countries following the World Governance Indicator 'Control of Corruption'. ESG factors of countries are integrated in the bottom-up country analysis. In the portfolio construction the fund ensures a minimum weighted average score of 6.5 following Robeco's proprietary Country Sustainability Ranking. The Country Sustainability Ranking scores countries on a scale from 1 (worst) to 10 (best) based on 40 environmental, social, and governance indicators. Lastly, the fund invests in a minimum of 10% in green, social, sustainable and/or sustainability-linked bonds. For more information please visit the sustainability-related disclosures. Country Sustainability Ranking

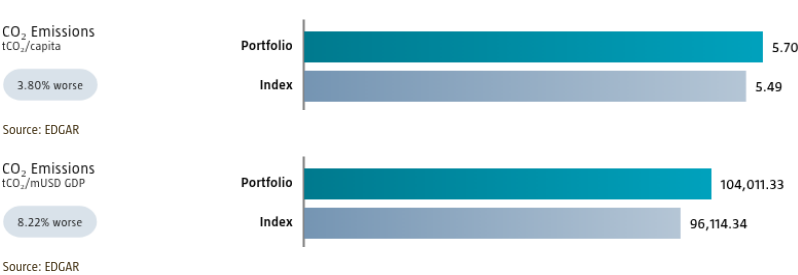

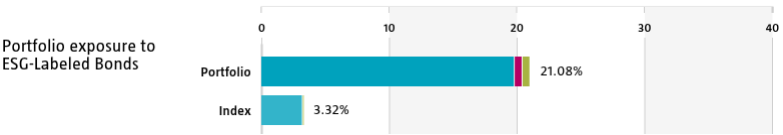
Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Index intensities are provided alongside the portfolio intensities, highlighting the portfolio's relative carbon intensity. Only holdings mapped as sovereign bonds are included in the figures.



ESG Labeled Bonds

The ESG-labeled bond chart displays the portfolio's exposure to ESG-labeled bonds. Specifically, green bonds, social bonds, sustainability bonds, and sustainability-linked bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

Country ESG scores are part of our bottom-up analysis.
