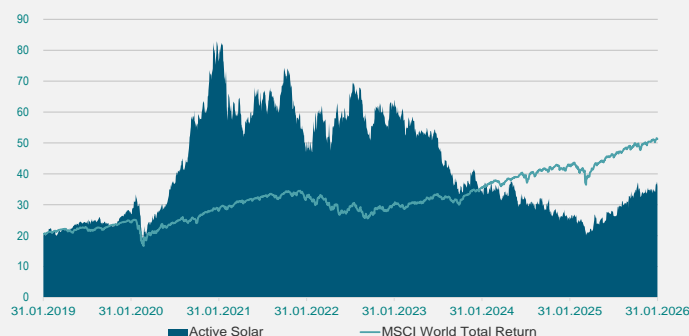

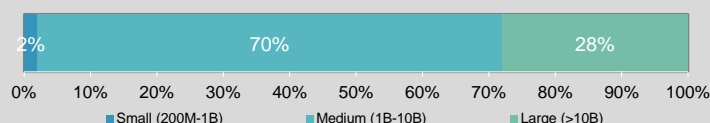

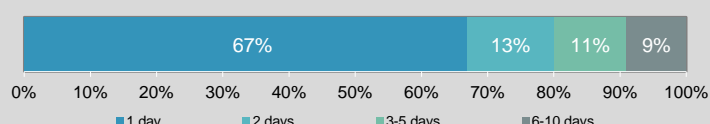

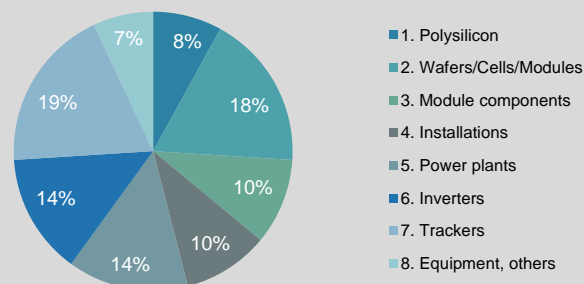
#### Market capitalisations of the companies
