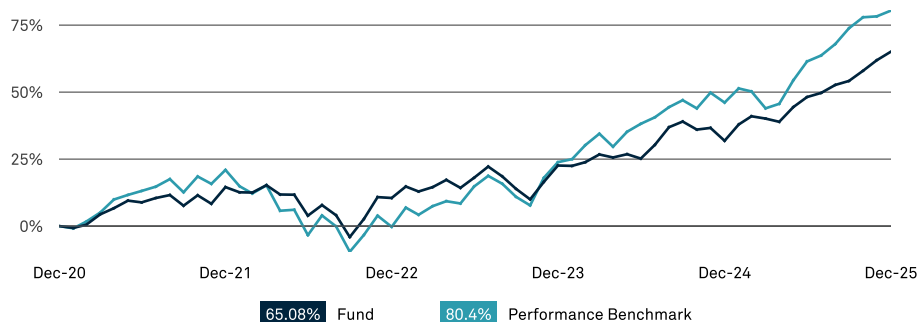

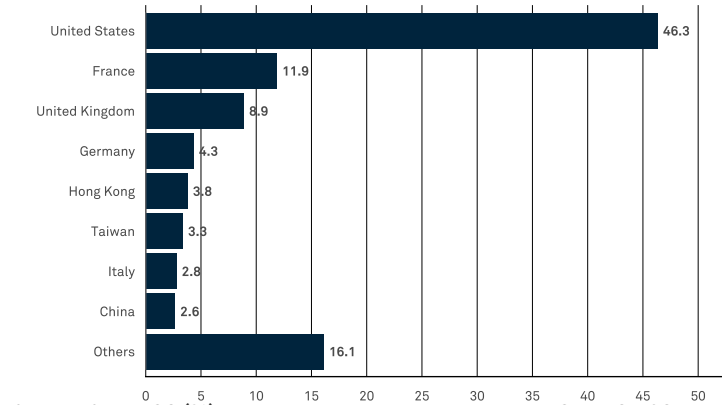

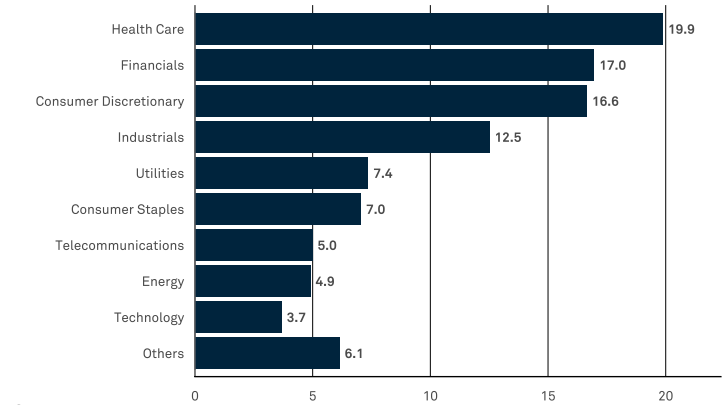

INDUSTRIAL ALLOCATION (%)



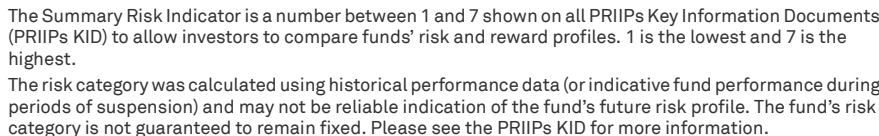
