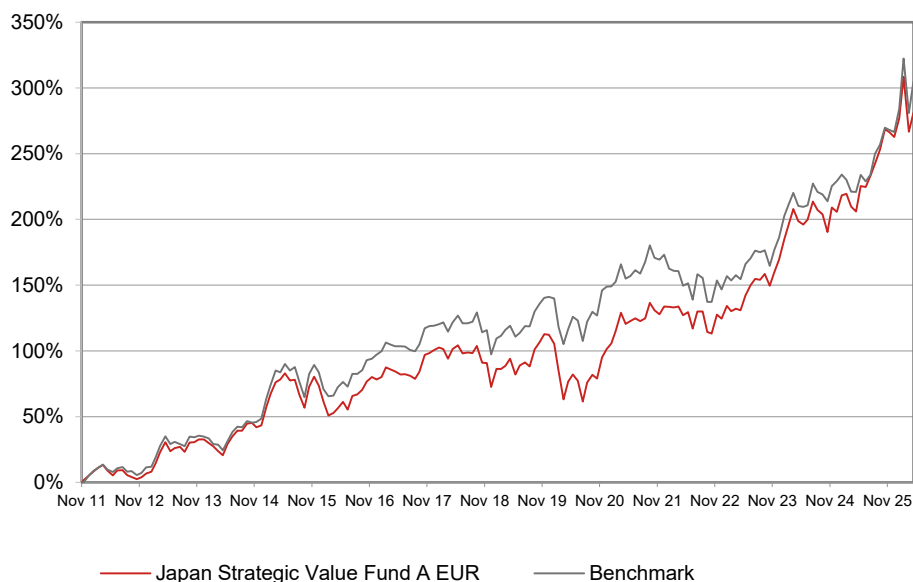


INVESTMENT OBJECTIVE

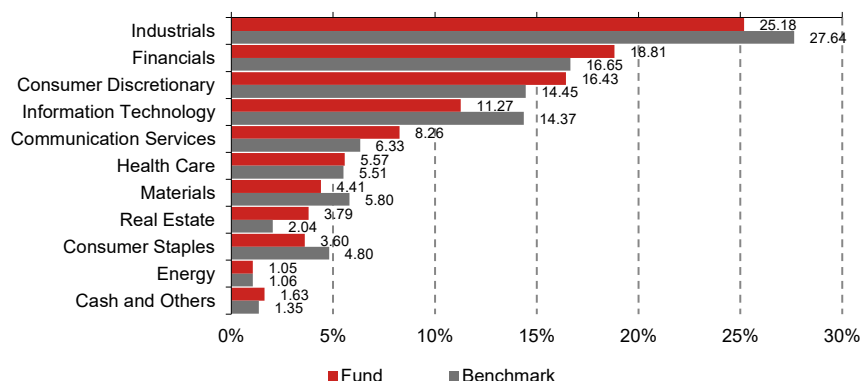
